As a condition of using our services for your pets, the following form must be signed.

Rules and Requirements

To ensure the health and safety of your pet and of our other guests, we require that all of our clients comply with the following rules and regulations.

1. To participate in daycare or boarding all dogs must be at least 5 months of age or older. All dogs over the age of 6 months must be spayed or neutered.

2. All dogs must have up-to-date vaccinations. Owners must submit written proof that their dogs have current Distemper and Rabies vaccinations. Bordatella vaccination and topical flea and tick preventative *highly* recommended.

3. All dogs must be in good health. Upon admission, all dogs must be free of any condition that could potentially jeopardize other guests, including fleas or ticks. Dogs that have been ill with a communicable condition in the last (30) thirty days will require veterinarian certification of health to be admitted or readmitted.

4. Owners will need to disclose if their dog(s) have harmed or shown aggression or threatening behavior towards any person or other dog(s).

5. All dogs must have a complete, up-to-date and approved application on file prior to attending any Good Mojo service or event.

6. Please, do not bring personal items like blankets, bones or toys for daycare or boarding. We provide the appropriate materials to dogs in our care.

7. If a pet that is presented for daycare is found to have fleas and/or ticks, it will be bathed at the owner's expense.

8. Dogs must wait at least 48 hours after applying topical flea and tick medication before coming back for any group play experience at Good Mojo.

Waiver, Health and Temperament

By choosing to utilize the services, participate in activities, or groom my pet(s) at Good Mojo Dog Center, LLC, I agree to the following:

1. I agree to pay the rates and charges that are in effect at the time my pet is at Good Mojo Dog Center, LLC. I am aware that extra charges may be incurred and I agree to pay them at the time of pick-up. Examples include, but are not limited to: late pick up in daycare and grooming, cancellation fees when less than 48 hours notice is provided, or flea and tick baths if a pet is found to have them while in daycare or boarding.
2. If my dog(s) participates in daycare, boarding or playgroup, I understand that an interactive play setting is not without some risk of injury, that despite all the dogs appearing healthy and being handled with care and foresight, dogs are not always predictable and the unexpected may occur. I recognize that the benefits of an interactive playgroup are valuable to my dog(s), and accept the potential risks. I further agree to pay veterinary/medical expenses incurred as a result of injury to or caused by my dog(s).
3. I understand that if my pet is not picked up within seven days of the appointed time, the pet may be considered Abandoned under RSA 438:18-20.
4. If my pet appears to be ill or injured I authorize Good Mojo Dog Center, LLC to engage the services of a veterinarian at my expense, to give other requisite attention, and to make whatever decisions are required for the pet's veterinary treatment. I agree to pay all veterinary charges incurred by my pet while in the care of Good Mojo Dog Center, LLC. I further authorize Good Mojo Dog Center, LLC to use any credit card information I may have on file to pay for such veterinary treatment providing Good Mojo Dog Center, LLC has made a good faith attempt to contact me. I will not hold Good Mojo Dog Center, LLC liable for failure to seek veterinary attention or for decisions made under this section.
5. I understand that Good Mojo Dog Center, LLC will exercise all reasonable diligence and care in the guardianship of my pet. I hereby waive and release Good Mojo Dog Center, LLC, its employees, owners and agents from any and all liability of any nature, for injury or damage, including that which may result from the action of any pet including my own, and I expressly assume the risk of such damage or injury, including personal injury to me or my property, while my pet and/or I participates in or attends any function of Good Mojo Dog Center, LLC, while on the grounds or the surrounding area thereto.
6. I understand and agree that Good Mojo Dog Center, LLC, its employees and volunteers will not be liable for any loss of my pet due to fire, theft, death, injury or elopement and I hereby agree to hold harmless Good Mojo Dog Center, LLC from any all claims for such losses unless due to the gross negligence of Good Mojo Dog Center, LLC or its employees.
7. I hereby indemnify and hold harmless Good Mojo Dog Center, LLC for any and all injury or damage done by my pet to other pets, people, including employees and guests of Good Mojo Dog Center, LLC, or to any property regardless of the owner of said property. I agree to be responsible for any injury caused by my pet to other pets or to any person, including but not limited to, staff of Good Mojo Dog Center, clients customers or visitors.

I understand that if my pet(s) has a history of aggression or biting, Good Mojo Dog Center, LLC reserves the right to refuse service and I hereby certify that I have disclosed if my pet(s) has any history of biting or aggressive behavior, or any other associated dangers towards humans or other pets.

9. I hereby certify that my pet(s) are in good health and have not been ill with a communicable condition in the last (30) thirty days and that they are free of fleas and ticks.

10. I understand that I am required to provide Good Mojo Dog Center, LLC documented vaccination records and hereby do so and/or authorize Good Mojo Dog Center, LLC to contact my veterinarian for such records and to keep the vaccination up-to-date for the duration of my dog's participation at Good Mojo Dog Center, LLC.

11. I hereby certify that any credit card numbers or related information I have provided to Good Mojo Dog Center, LLC is valid and current. I hereby authorize Good Mojo Dog Center, LLC to charge against said credit card any and all valid and appropriate fees and charges owed by me, including cancellation fees, veterinarian fees and normal fees for service.

12. I hereby declare to Good Mojo Dog Center, LLC that I am the legal owner of my dog; that my dog has not been exposed to distemper, rabies, parvo, or any other communicable diseases within the past (30) thirty days; that my dog has been inoculated as indicated by records presented; and that I (the owner) have read this agreement in its entirety, accept all terms, rules, requirements, conditions and statements of this agreement.

On behalf of myself and any and all other owners of this pet, I have read and agree to the terms of this contract. I warrant that I have the authority to represent any and all other owners of this pet in signing this contract.
